FUN DAY REGISTRATION

FEES:

\$50.00/day per child

*If your child has not attended YMCA Before/After School in Cuyahoga Falls/Stow/Woodridge or Riverfront YMCA Day Camp in the past year, you will need to fill out a BASE registration packet for your child. Please write "Fun Days ONLY" on the first page.

Fees will be auto drafted 3 days PRIOR to date of service. Registration deadline is 3 business days prior to the date of care. Registrations will not be accepted if there is more than a one week balance on your account.

CANCELLATION POLICY: Notification must be given no later than one week in advance. Otherwise, I understand that I will be responsible to pay for the fun day, regardless of attendance.

PFCC (TXX) Recipients – There are no extra PFCC/TXX copays. You must TAP your child in and out with the tablet. **Authorization for Riverfront is required**, it is a separate site from Before & After School. The license number for Riverfront is 301735. Private pay charges will be applied to your account until you have successfully tapped or a TXX absence day has been utilized for the Riverfront location. If you have not tapped for the Fun Day within two weeks, your account on file will be charged the private pay rate.
